# DRAFT CYNGHOR CYMUNED CAPEL CURIG COMMUNITY COUNCIL

Minutes of meeting held at 19.30 hrs on Wednesday 4<sup>th</sup> December 2024.

**Minutes:** The draft minutes of the meeting held on 16<sup>th</sup> October 2024 were approved without amendment.

## **Matters arising:**

**Street Lights:** All now installed and working with the exception of one light near Pont Cyfyng turn off. Clerk to enquire if these new lights will be allocated numbers so faulty lights can be identified clearly.

**Sewage at Bryn Glo:** There was an outage on Weekend 23/24 November, but no raw sewage reported.

**Bridge by Fferm Royal:** Clerk said he had written after the last meeting, 16/10/2024 suggesting red traffic rumble lines should be put on the road as a possible way of slowing traffic. He had then written again on 20<sup>th</sup> November asking when work would commence having been previously told that work would not start before 3 September and asking for any comments on the red line suggestion. Correspondence sent to Daniel Durrans at Conwy County Council. Reply received from Conwy 28<sup>th</sup> November stating they would consider the red line proposal, and they were currently waiting on a start date from the appointed contractors. Conwy apologised for the delay.

**A5 Road:** Work had now been completed – obvious defects in the road had been 'patched' Traffic Wales had responded very quickly to Clerks correspondence. They had taken note of the seepage onto the road west of Joe Browns Shop and made some effort to rectify the

situation but it would seem that there may be an underground spring in the area with water coming up through the tarmac.

**Audit Wales:** We have settled the outstanding invoices valued at £2975.26

**Drop in Session – Rural Digital Connectivity:** This session had to be postponed due to adverse weather –However as the project is shortly ending the group have suggested residents might like to attend in Dolwyddelen, at the Pavillion on 11<sup>th</sup> December between 10am and 2pm - agreed to advertise on notice boards immediately.

**New Capel Curig Website:** Clerk reported he had briefed the web technician, Nick Ferguson, of Gron Glwyd, Cerrigydudion on 24<sup>th</sup> October and we await a progress report. Clerk said he hoped we would be in a position to launch the site early 2025. He thought the site would be far more flexible and as a Council we would be able to post information in line with good and legal practice far more effectively.

#### **Financial Matters:**

Clerk reported that the full audit report for the period 2023/2024 has now been received. Our accounts are "Qualified" however 'Except for the matters reported below in my Basis of Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return'

The Clerk said the full report would be attached electronically to the minutes and also uploaded on the new website.

The points raised could in general be rectified by slight changes in procedures and Council discussed this fully.

We are required to display on the Notice Boards the Notice of Conclusion of Audit and Right to Inspect the Annual Return for year-end 31<sup>st</sup> March 2024. This will take place from the 5<sup>th</sup> December 2024 for 14 days

It was agreed that any person requiring photocopies of the report would be charged £5.00p Budget:


The revised budget, after the recent issues with non-submission of accounts, were presented to Council.

#### **Public Footpath signs Fferm Royal land:**

The farmer had explained that the footpath from the War Memorial towards the area known as the Pinnacles was a very busy area. He is constantly having the gate left open. It was agreed that we should should help and Chair said he would contact the Carneddau Project to see if they would supply a more suitable self-closing gate.

# **Public Toilets – Capel Curig**
